It gives me great pleasure to introduce to you the Holmes County General Health District 2018 Annual Report, which provides an overview of programs, services, events and accomplishments from the last year, and highlights the direction the Health District has gone to prevent, promote, and protect the health of Holmes County.

In 2018, the Health District completed document submission to the Public Health Accreditation Board and is awaiting a site visit in June to determine accreditation eligibility. The Community Health Assessment (CHA), Community Health Improvement Plan (CHIP), and Strategic Plan became a focal point in staff and community collaborative meetings. The Health District continued to focus on improving the health and well-being of Holmes County by applying essential community feedback from the CHA and CHIP to dedicate resources to priority areas while advancing the mission of the Health District. It was encouraging to see this alignment.



AMISH HEALTH & SAFETY AUGUST 14

The Holmes County General Health District, in collaboration with the Holmes County Safe Communities coalition, and community partners, hosted the 19th annual Amish Health and Safety Day at the Mt. Hope Event Center. Every year, community partners are invited to participate and share programs, services, or educational topics to improve health and safety in the Plain Community. Last year, the Health District provided administrative support for the event and promoted Health District programs and services at several vendor booths. WIC, Injury Prevention, BCMH/Immunizations, Emergency Preparedness, Early Intervention and Help Me Grow were all represented at the event. Amish Health and Safety Day provides the Health District with a unique opportunity for outreach to the Amish community

HOLMES COUNTY FAIR AUGUST 6-12

The Holmes County Fair is always a fun time for the community and the Health District, and provides our agency with a great opportunity for outreach. Several of our programs were represented throughout the week at the fairgrounds. The Health District had a booth set up throughout the week, and had a corn hole game, where visitors could win prizes. On Kids Day, we brought back our Hand Washing Station, teaching kids that washing their hands the right way is important, and fun! WIC hosted a table for Kids Day, where they had a basketball hoop game, and gave away smoothie samples and toasted chickpeas as healthy snacks. On Senior Day, Kerry MacQueen, Injury Prevention Coordinator, did a presentation and demonstration of Tai Chi. Jessica Boal, Nursing Director at the Health District, did a presentation on how to build an emergency preparedness kit.



EVENTS

FLU CLINIC AT WEST HOLMES OCTOBER 9

In order to practice and enhance our emergency preparedness capabilities, each year the Health District conducts a community flu clinic. These clinics test our ability to open up a Point of Distribution (POD) site to administer vaccines. During a public health emergency, the goal of a POD is to immunize or provide medication to as much of the population as possible during a short amount of time in order to prevent the spread of a communicable disease. We work with our local school districts for this event. Last year's flu clinic was held at West Holmes High School. We provided flu shots to 36 adults and 9 children.





SEWAGE CONTRACTORS MEETING NOVEMBER 6

On November 6, 2018, the Holmes County Health District hosted the 3rd Annual Sewage Contractor Continuing Education Training Conference. Speakers representing the Ohio Bureau of Workers Compensation, the Ohio Department of Health, as well as nationally recognized wastewater technology companies Anua, Presby Environmental, Inc., and Hydro-Action partnered with the Health District to provide this educational opportunity to 159 conference attendees representing 25 Ohio counties. Presentations covered such topics as job-site safety procedures, the importance of thorough documentation, peat fiber bio-filters, wastewater treatment alternatives and the process of flow equalization.

HEALTH DISTRICT HIGHLIGHTS



FALLS WALK

At the 5th Annual Falls Prevention Walk, Tia Gulley, from the Ohio Department of Aging, presented Kerry MacQueen, Injury Prevention Coordinator, a certificate awarding the Health District for being an Outstanding Partner in the Ohio Department of Aging and Steady U Ohio's "10 Million Steps to Prevent Falls" campaign. The annual event is used to promote falls awareness and prevention for adults 60 + with the message that falls is not a normal part of the aging process. There were 100 participants at the event in 2018, up from 64 in 2017. Holmes County contributed 447,020 steps in the "10 Million Steps to Prevent Falls" campaign.

ACCREDITATION

For the last several years, the Health District has been working to achieve accreditation through the national Public Health Accreditation Board (PHAB). Being an accredited health department would mean that we adequately provide our community with the 10 essential public health services. Additionally, being accredited by PHAB will help to ensure that public health services stay local, within in Holmes County, as opposed to being regionalized. Achieving accreditation includes an intense document review and collection process followed by a site visit from PHAB. We are happy to report that the health district submitted all required documentation to PHAB on August 1, 2018. Our site visit is scheduled for June 4-5, 2019. We hope to find out our accreditation decision in the fall of 2019.
